Adoption Terms

- 1) An adoption fee of \$_____ will be paid at the time of adoption.
- 2) N.A.L.W.C.. LLC will disclose any and all information known about the dog to the adoptive owner.
- 3) Adoptive owner has been urged to research the breed of dog being adopted.
- 4) Adoptive owner understands that the dog may go through a transitional period when arriving into a new environment. Care will be used to introduce the dog, as appropriate, to other family members and/or animals that reside in the household.
- 5) Adoptive owner agrees to provide proper care to the adopted dog. This includes preventative and emergency care provided by a licensed veterinarian as well as meeting proper nutritional needs and grooming needs.
- 6) Adoptive owner agrees to provide a safe, clean, and happy environment for the adopted dog. This includes providing the dog with social interaction, mental stimulation, and an appropriate level of exercise. They also agree to provide a safe area, such as a fenced yard, when supervision is not available. The adopted owner agrees to be actively involved with the adopted dog.
- 7) Adoptive owner understands that the dog has been worked with in the following areas:

Furthermore, respect will need to be established within the new family structure and adoptive family is willing to commit the time needed in obtaining that.
- 8) Adoptive owner is willing to allow an N.A.L.W.C. representative visit the home for follow-up visits.
- 9) Adoptive owner understands that the dog is being adopted with the expectation that he/she will be used as a working dog and/or a family companion. If, for whatever reason, the adoptive owner can not keep the dog, the dog must be returned to N.A.L.WC. unless a

mutual agreement is made between the adopter and N.A.L.W.C. to transfer ownership to a third party. The third party would have to agree to the terms set forth by N.A.L.W.C.

- 10) If the dog is lost, the adoptive owner agrees to notify N.A.L.W.C. within 24 hours.
- 11) The Adoptive owner understands that ownership is assumed by the adopter at the time of adoption. N.A.L.W.C will not be held responsible for ownership responsibilities once adoption agreement signed and dated.

In the event the dog is too young to be neutered or spayed at the time of adoption, the adoptive owner agrees to perform the surgery when the dog reaches an appropriate age..

The adoptive owner understands that N.A.L.W.C has the right to recover the adopted dogs if any of the terms of this agreement are not met. _____ (initial)

The adoptive owner understands that assuming ownership of an animal warrants prudent care and knowledge and are able to demonstrate the ability to properly handle and care for the dog and any behaviors that may arise.

The adoptive owner has interacted with the adopted dog, prior to adoption, and is qualified to assume responsibility. _____ (initial)

N.A.L.W.C., LLC has provided all the information needed for the adoptive owner to make an informed decision. _____ (initial)

By signing below, the adoptive owner understands and accepts that full ownership responsibilities belong to the adoptive owner. The adopted dog is provided “as is”. All warranties, including implied, are hereby specifically disclaimed.

N.A.L.C will not be held accountable for any bodily injury, property damage, or death, to the adoptive owners or any person(s) as a result of behavior and/or actions from the adopted dog.
